



## RULES OF THE INTERNATIONAL SPEECH-TO-TEXT INTERNET COMPETITION 2026 – 2<sup>nd</sup> edition

### 1. Structure of the competition

The International Speech-to-text Internet Competition 2026 consists in the **real time** transcription of an audio in the competitor's mother tongue for a duration of 10 minutes, dictated at increasing speed, according to the competitor's language as per the following table:

Specifically, the column to be followed will be determined based on the competitor's mother tongue.

## 2. Registration

Registrations start at midnight (12 am CET) on January 07, 2026 and end at 23:59 (11:59 pm CET) on January 31, 2026. [Click here to register for free.](#)

You can participate with the technique and/or technology you prefer to transcribe the text. Two separate classifications will be redacted: one for competitors using a standard keyboard and one for competitors using any other technology. ## 3. Modalities

Competitors can take part in the competition on the on-line platform MARS. Competitors can participate autonomously by accessing the platform with their personal credentials from **midnight (12 am CET) on February 1, 2026 to 23:59 (11:59 pm CET) on February 8, 2026**. Competitors can compete at any time of the day or night within the given competition period. The link to the platform and the credentials will be provided, only to registered competitors, the day before the beginning of the competition period. **Access to the platform to compete is allowed once.** No exceptions are allowed.

It is recommended to use headphones during the competition. Training is possible on the website <http://reachmars.eu/>.

## 4. Procedure

- Follow the provided link;
- enter your personal credentials;
- when you are ready to start, click on "Start"; the audio track will start and you will be able to transcribe immediately (the cursor is already in place);
- corrections are allowed only while you are transcribing the audio;
- once you can no longer continue transcribing, click on "Stop";
- the results, but not the placement in the classification, will be shown immediately.

An e-mail will be sent one day before the end of the competition period to competitors who have not yet competed.

## 5. Evaluation

To qualify for a certain minute, the competitor's accuracy for that minute must be greater than or equal to **98% (2% max. errors)**. In that case, corrections will move on to the next minute and so



on until the end. If the competitor does not qualify for a certain minute, the software will stop correcting and consider the last valid minute for the sake of the classification.

A competitor, to be admitted to the classification, must qualify at least for the **third minute**.

The accuracy is automatically calculated as follows:

$$(1 - (\text{number of mistakes} / \text{number of characters in the minute})) * 100 \%$$

where “number of mistakes” means the total number of **additions**, **substitutions** and **removals** from the original text. A maximum of one error is counted per word, unless subsequent errors in the same word are more than 10 characters apart.

Punctuation is not evaluated for scoring. However, competitors must still use correct punctuation when transcribing the text, or they will be disqualified.

All the evaluations will be automatic. Only the first 3 places will be manually checked.

## 6. Grounds for disqualification

The reasons for being disqualified from the competition can be:

- correcting the transcribed text while the dictation is still running (for example, the competitor decides to stop transcribing at minute 5 and starts correcting first 5 minutes while the dictation continues); if the competitor can no longer follow the audio, they must submit the work clicking on “Stop” within 10 seconds;
- recording or downloading the audio source to know the contents of the dictation in advance, or to supply other competitors with the audio;
- ignoring the use of punctuation.

## 7. Classification

Two separate classifications are drawn up: one for competitors using a standard keyboard and one for those who use any other technology. Competitors reaching a higher valid minute will be classified before those with a lower minute. Between competitors classifying in the same minute, the most accurate one will qualify higher.

The classifications are published within 48 hours after the end of the competition on onA.I.R. website, on Intersteno website and on their social media.

A certificate will be sent digitally to all competitors who are successful and their teachers/mentors.

## 8. Complaints and information

E-mail complaints are allowed within seven days of the publishing of the final classifications. You will receive a response within seven days of receipt of the complaint email. The contact email address for the competition is [intersteno@respeakingonair.org](mailto:intersteno@respeakingonair.org).
